

STRUCK BY A STREET CAR

COUNTRY PEOPLE HAVE A NARROW ESCAPE.

Wagon Smashed and Occupants Injured in a Collision This Morning.

Two young men named Elmer came near being seriously injured on Twenty-fifth street this morning. At the time they were driving across Lincoln avenue on Twenty-fifth street, and at the same time a Twenty-second street car was coming down the street. The men did not notice the car until it was upon them, and then it was too late for them to get out of the way.

The car struck the wagon, throwing it against the pole in the center of the street and hurling the men to the pavement. Fortunately the men were not badly hurt, but the wagon was nearly wrecked. After the accident the injured were able to proceed to their home in Marriotts Lane.

SAUCER TRACK RIDERS

Unfair Tactics Are to Be Charged Against Professionals.

The trouble that arose last evening at the Ogden saucer track over the two-mile open lap professional race may result seriously for at least three of the leading riders. It is understood that complaints are to be filed today with Referee Shefski, accompanied by the statements of several of the riders, that a deal had been pre-arranged between Samuelson, Hopper and Bowler, for a three-man team, and that they carried out the deal to the letter, to the detriment of the other riders. Whether this is true or not there is no way for the judges to determine. Under the rules of the N. C. A., two riders may team, as they so publicly announce before the race starts. In this case Hopper and Samuelson announced that they would team, but Bowler was not mentioned. Now come the other contestants in the race, and claim that Bowler was also in the team and that the trio completely shut them out. In substantiation of their claim they allege that they were warned to look out for Hopper and Samuelson, as Bowler was to "pull" them both. This was the direct cause of the personal encounter between Hopper and Redman in the dressing room after the race.

One thing is certain, however, Manager Heagren and Referee Shefski are determined that all foul riding shall stop, and that the patrons of the track shall be given good, clean sport, and to that end the inside of this matter is to be thoroughly sifted and the facts presented to the national board for its action.

OGDEN TEAM IN NORTH

Umpire Has so Far Aided in Defeating Them.
